21. Apologies for Absence

Received from Cllr Josh Wheeler, also from District Cllr Philip Burford.

22. Declarations of Interest

23. Public Consultation

No matters were raised.

24. Planning

Planning Responses

To discuss planning applications in the Parish and agree to any comments.

- (i) P0598/25/FUL Coniston Cottage, Road From The Causeway To Junction With The Lottery, Redmarley, GL19 3HS. Erection of a replacement self-build residential dwelling with associated landscaping and works. Demolition of existing dwelling. After consideration there were **no objections**. It was agreed to ask for a condition to ensure the provision of nesting facilities given the abundance of birdlife to be found on and directly adjacent to the site in question.
- (ii) P0567/25/TCA Foxfield Road From The Causeway To Junction With The Lottery Redmarley. Fell and remove a large Norway Spruce (Tree 1) planted in the garden. It is now a large tree easily within toppling distance of Foxfield and its dense canopy is affecting the shrubs underneath which are becoming straggly. Fell and remove a Silver Birch (Tree 2). as it is in the location of a proposed new dwelling proposed under Planning Application P0452/25/FUL.

The unanimous view was to **object** on the basis that it is entirely inappropriate to consider this matter until such time as a decision has been reached regarding application P0452/25/FUL.

Consideration was given to seeking a Judicial Review into various aspects pertaining to the cases. It was **agreed** that it may be necessary to register intent to request a judicial review in a timely manner and it was further **resolved** to seek legal advice before going ahead.
